STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

The Charity is a Scottish Charitable Incorporated Organisation (a SCIO) with a two tier structure. It was registered in its current legal form on 15 July 2020. The charity was previously a Company Limited by Guarantee. The assets of the Company Limited by Guarantee were transferred to the SCIO on 15 July 2020.

Recruitment and Appointment of Trustees

The Trustees are elected by members at the annual general meeting. Up to three Trustees may be co-opted by the elected Trustees.

Governing Document

Kilmaronock Community Trust is a Scottish Charitable Incorporated Organisation governed by its constitution.

CHARITABLE PURPOSES

The Organisation's main purpose is consistent with furthering the achievement of sustainable development. The Organisation's purposes are:

- To provide or advance the accessibility of recreational, facilities, and/or organising recreational activities, which will be available to members of the Community and public at large with the object of improving the conditions of life of the Community.
- Advancement of citizenship or community development, including rural or urban regeneration.
- To advance the provisions for educational opportunities in the Community relating to environment, culture, heritage and/or history.
- To advance environmental protection or improvement including preservation, sustainable development and conservation of the natural environment, the maintenance, improvement or provision of environmental amenities for the Community and/or the preservation of buildings or sites of architectural, historic or other importance to the Community.

RECRUITMENT AND APPOINTMENT OF TRUSTEES

At the first AGM as a SCIO (19 February 2021) Bob Shand, Steve Macken, Elaine Ellen, Mary Sweetland, Andy Sinnott and Samantha Morrison were all elected as Trustees.

COMMUNITY ACTION PLAN

The Kilmaronock Community Action Plan 2016-2020 forms the basis of KCT activities. It is developed with LL&TNPA, KCC, RSPB, WDC, the community and other interested parties. The plan will be updated when the Local Place Plans procedures are known. It is anticipated that more information will be available on this in early 2022. The current Community Action Plan is available to view via the Gartocharn Website – gartocharn.org.

MEMBERSHIP

KCT had 28 full members in the current financial year.

ACTIVITIES AND ACHIEVEMENTS

It has been a very unusual year due to the ongoing Covid-19 crisis which has resulted in no indoor face-to-face meetings and curtailed opportunity for engagement with funders, contractors or each other. The Trustees have continued to hold meetings online and have made significant progress on grant applications for footpath repairs and in completing work on other projects.

FOOTPATHS AND ACCESS

Aber Dam Bridge: In September 2020 KCT were awarded funding to replace the wooden decking on this bridge and had the materials delivered. Unfortunately, but identified by us as a risk, the supporting wooden beams had significant rot and after expert assessment it was determined that this is a safety hazard and the path had to be closed pending a solution. Eventually a further grant application was made to replace the whole bridge and in early September 2021 KCT heard that this was successful, although additional work is needed to obtain alternative quotes. The Aber Path has been out of use all summer with alternative routes signposted.

Duncryne Path: Having lost out in a National Park Grant application in 2020, KCT were fortunate to be awarded funds by NatureScot, under their Green Recovery Fund. The work was completed in July 2021 apart from new signage.

KCT wish to record their thanks to Alan McMullen and his team at WDET who have overseen the tendering and implementation of both these projects.

COMMUNITY ULTRAFAST BROADBAND

KCT has concluded its engagement with Openreach to try and obtain a FTTP service across our community. The Trustees are disappointed that the scheme could not deliver what was needed and hope that the new R100 initiative will provide the broadband that people need on an individual basis.

FOOTBALL PITCH AND PLAYGROUND

Both these projects are now complete and the facilities in full use. It is still hoped that something may be done in the future to address the remaining boggy area. Gartocharn FC have now played several home games on the new pitch.

LOCAL PLACE PLAN

Activity is now starting, along with Kilmaronock Community Council and other village groups, to engage with our community on a Local Place Plan to replace the current Community Action Plan. This will form the basis for future project work and for the National Park Authority's Planning policies for our area until 2034 and therefore is a very significant piece of work.

Finally the Trustees would like to record their thanks to Janet Beveridge who stood down as a Trustee after many years of dedicated service and to Andy Sinnott and Sam Morrison who agreed to become Trustees.

RESERVES

The Trust had a surplus of £1,049.32 (including £941.38 restricted funding for repairs to Aber Bridge) in the year ended 31 August 2021 and this has been transferred to our reserves. The reserves at the year-end are £6,168.36.

The Trust will continue to seek funding for projects from various sources when the opportunities arise.

The accounts are prepared on a Receipts and Payments basis.


