## STRUCTURE, GOVERNANCE AND MANAGEMENT

## Constitution

The Charity is a Scottish Charitable Incorporated Organisation (a SCIO) with a two tier structure. It was registered in its current legal form on 15 July 2020. The charity was previously a Company Limited by Guarantee. The assets of the Company Limited by Guarantee were transferred to the SCIO on the 15 July 2020.

## **Recruitment and Appointment of Trustees**

The Trustees are elected by members at the annual general meeting. Up to three Trustees may be co-opted by the elected trustees.

## **Governing Document**

Kilmaronock Community Trust is a Scottish Charitable Incorporated Organisation governed by its constitution.

## **CHARITABLE PURPOSES**

The Organisation's main purpose is consistent with furthering the achievement of sustainable development. The Organisation's purposes are:

- To provide or advance the accessibility of recreational, facilities, and/or organising recreational activities, which will be available to members of the Community and public at large with the object of improving the conditions of life of the Community.
- Advancement of citizenship or community development, including rural or urban regeneration.
- To advance the provisions for educational opportunities in the Community relating to environment, culture, heritage and/or history.
- To advance environmental protection or improvement including preservation, sustainable development and conservation of the natural environment, the maintenance, improvement or provision of environmental amenities for the Community and/or the preservation of buildings or sites of architectural, historic or other importance to the Community.

## **RECRUITMENT AND APPOINTMENT OF TRUSTEES**

Robert Shand retired by rotation and agreed to be co-opted. Elaine Ellen was elected. (Andy Sinnott attends meetings to represent Kilmaronock Community Council.)

### **COMMUNITY ACTION PLAN**

The Kilmaronock Community Action Plan 2016-2020 forms the basis of KCT activities for the coming years. It is developed with LL&TNPA, KCC, RSPB, WDC, the community and other interested parties. The intention is to update the plan but this cannot be done until the Local Place Plans procedures are known. The current Community Action Plan is available to view via the Gartocharn Website – gartocharn.org.

## **MEMBERSHIP**

KCT had 25 full members in the current financial year.

#### **ACTIVITIES AND ACHIEVEMENTS**

KCT has delivered a variety of projects in recent years, including improvements to the football pitch, enhanced facilities in the play park, a home energy audit and the toposcope at the rear of the Kilmaronock Millennium Hall.

## **Paths and Access**

KCT Paths Group continue to liaise with the National Park Access team and our community and landowners in matters of access and paths including consultation on the Core Path Network. We submitted Grant Applications to cover repair work on two local paths - the Dumpling and Aber Bridge - and are hopeful that at least one of these projects comes to fruition in 2020/21. There is still an intention to develop a path that can access the War Memorial and KCT are also in contact with RSPB Loch Lomond regarding further enhancement of the local path network.

## **Ultrafast Broadband Project**

The FTTP (Fibre to the Premise) project has not progressed during this financial period. Openreach completed their detailed survey in December 2019 but will not provide a detailed quote, suggesting instead that we wait to see what the R100 scheme will bring to the area. KCT are very disappointed about this and have requested full details of the R100 as soon as possible. All those who expressed interest have been kept informed.

#### **Football Pitch Improvements**

Work has been completed and the pitch was ready for use in Spring 2020. Due to the restrictions imposed in respect of Covid 19 no use has been made of the pitch this year.

## **GRANT AWARDS**

- KCT were grateful to receive a grant of £240 from LL&TNPA for general administration costs.
- KCT were grateful to receive a grant of £350 from Shell UK for general administration costs.

#### GIFT AID

KCT received £42.50 in this financial year.

## **RESERVES**

The Trust had a deficit of £3,251.80 in the year ended 31 August 2020 and this has been transferred from our reserves. The reserves at the year-end are £5,119.04.

The Trust will continue to seek funding from The Loch Lomond and the Trossachs Community Grants Scheme towards running costs. Funding for projects will be sought from various sources when the opportunities arise.

The accounts are prepared on a Receipts and Payments basis.


